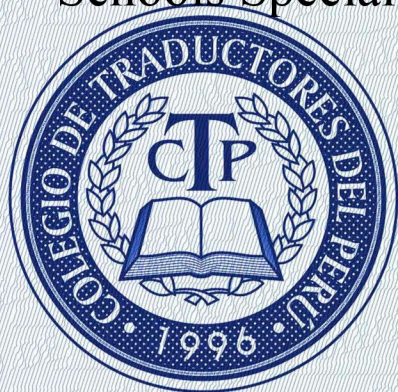

### **INSTITUTIONAL POLICY**

#### **Anti-bribery Management System Policy of the Bicentennial Schools Special Public Investment Project – PEIP EB**

#### **I. ANTI-BRIBERY MANAGEMENT SYSTEM (SGAS) POLICY**

In the Bicentennial Schools Special Public Investment Project, referred to hereinafter as the PEIP Bicentennial Schools of the Ministry of Education, we implement sustainable viable or approved investments, as appropriate, which have budget availability for their execution, and which close the infrastructure and access gap in public services; ensuring the effective provision of education services for the benefit of the country.

In this context, the PEIP Bicentennial Schools (Implementation Unit N° 125), in accordance with the provisions of the National Policy on Integrity and the Fight against Corruption approved by Supreme Decree N°. 092-2017-PCM, expresses its commitment to fight head-on against bribery and corruption, and its firm decision to adopt all necessary measures to combat such actions, and undertakes itself to:

- a) Prohibit, report and punish bribery in all its forms, as well as the obtaining of undue advantages, and the acceptance of gifts, hospitalities and other benefits.
- b) Promote and encourage an ethical culture by raising awareness and training all employees; informing interested parties of our commitment to anti-bribery management and the consequences of engaging in this crime.
- c) Ensure that there is no retaliation when concerns are reported in good faith or on the basis of reasonable belief, without fear of retaliation for the reporting of bribery cases.



- d) Apply administrative disciplinary measures and/or request the launching of investigations in any proven case that violates this policy, through the appropriate instances; also, the Anti-Bribery Compliance Function will exercise with authority and independence the position designated by the Executive Directorate.
- e) Promote and ensure the continuous improvement of the Anti-Bribery Management System, and compliance with the legal, regulatory and other requirements applicable to the entity.
